- Flyers may be passed out to anyone to maximize your return prior to the scheduled event. Anyone suspected of passing out flyers on the day of the event on **JOHN & TONY'S** property will cause a penalty deduction or forfeit the entire donation.
- The flyer must be turned into your server at the time of payment along with a copy of your bill to receive credit for the donation. Once you've left the building, you may not return with a flyer to apply to your bill.
- Although groups may request sitting in the same section when booking the event, it is not necessary, to receive the donation. We may not be able to grant all seating requests.
- **20% of the pre-taxed discounted bill** will be donated by **JOHN & TONY'S** back to the **"EAT OUT 4 CHARITY"** organization/group.
- Your donation check will be ready for pick up on the second day after your event. We will hold all checks for you up to 7 days.
